For fifteen years, Audubon International has managed education and certification programs for members of the golf industry—the Audubon Cooperative Sanctuary Program for Golf Courses and the Audubon *Signature* Program. As a result, over 2,300 golf courses are currently members, and 3% of all golf courses in the United States have completed all of the programs' environmental requirements in order to be called a Certified Audubon Cooperative Sanctuary.

As the only environmental organization working to actively promote environmental stewardship on golf courses through education and certification programs, we are taking this opportunity to re-commit ourselves to working with all members of the industry—golf course owners, managers, superintendents, and staff, professional associations, developers, and any company or organization associated with the game of golf. We pledge to continue to solicit industry-wide stakeholders for advice and ideas that will help us manage more reasonable and effective environmental programs.

We pledge to work in a collaborative fashion with all stakeholders in order to find a way to have fifty percent of all courses in the United States involved with our education and certification programs.

We also pledge to work diligently with these stakeholders to improve environmental performance in the entire golf industry, while also helping to highlight and publicize these voluntary efforts.

With this re-commitment, we are asking you—the leaders who make up the golf industry—to pledge your commitment to Audubon International's environmental goals as well.
